I. INTRODUCTION

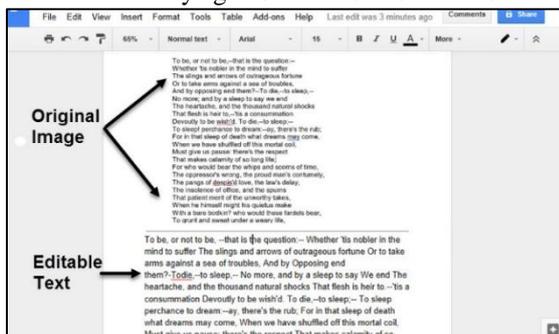

In the existing scenario we have OCR technique which is use to identify or recognize the character/text from the document and the image.

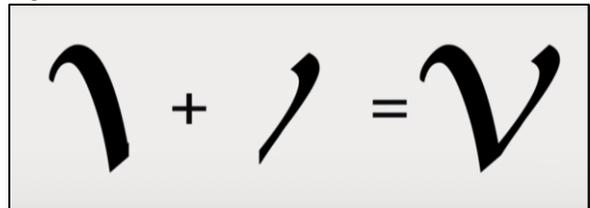
This techniques can be the most powerful to prevent the fraudulent activity against the false documents.

To overcome the current problem we can have a new techniques which is Paper OCR, which is purely based on the OCR and the OMR.

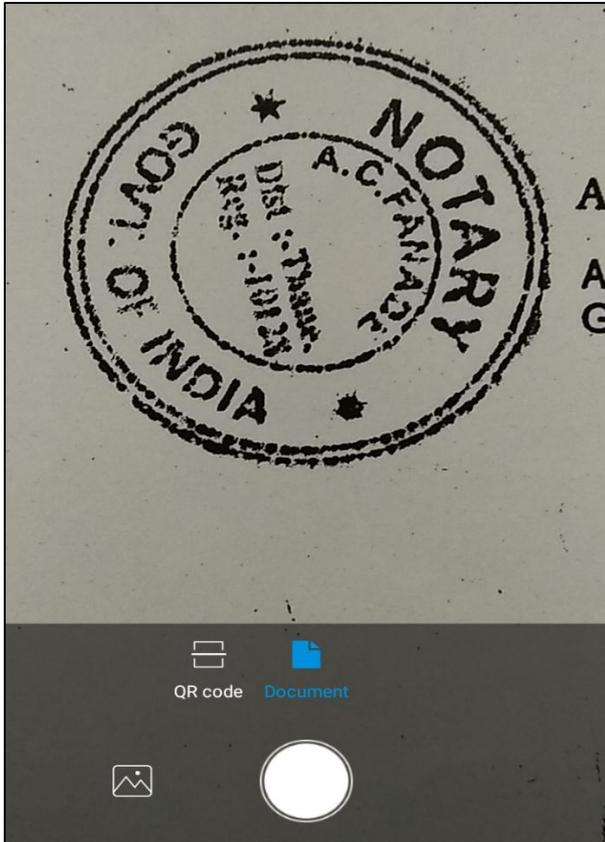
In this technique we have one example to read a logo from the Paper OCR, the image can be capture by the android phone, it will scan the image and produce its authenticity that what is text written on it.

It follows the some steps include:

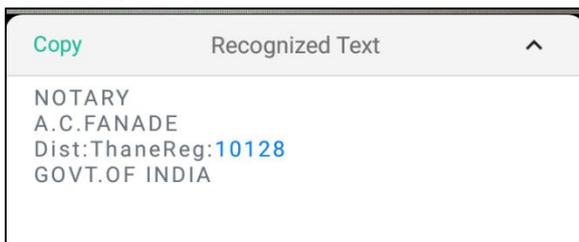
- It convert the image to its gray scale,

- Watermark can be read with the help of OMR and OCR which is mixed in algorithm, it will find the exact pattern to identify the logo, watermark.

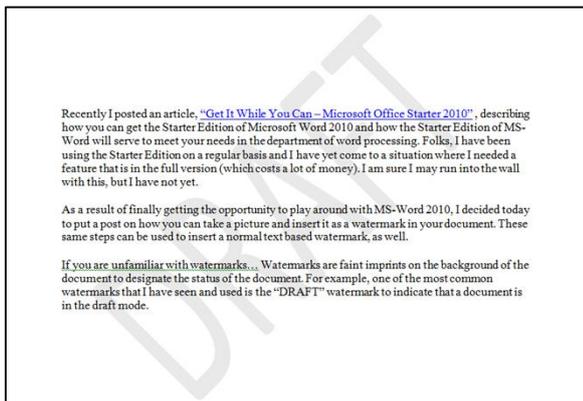

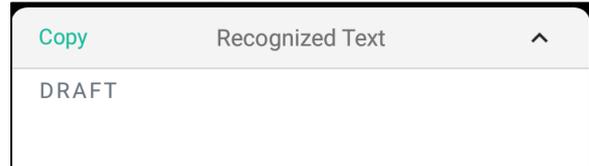

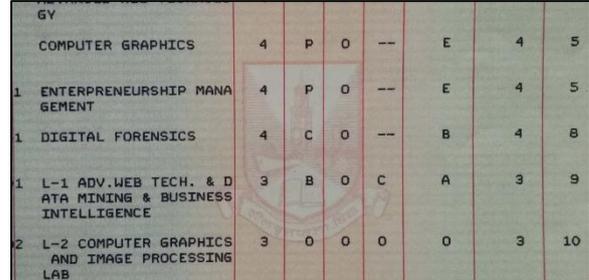
Another example is to detect the watermark inside the document.



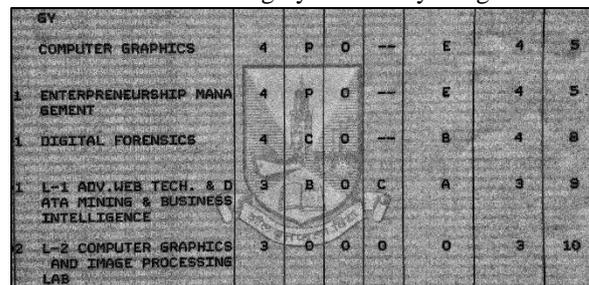

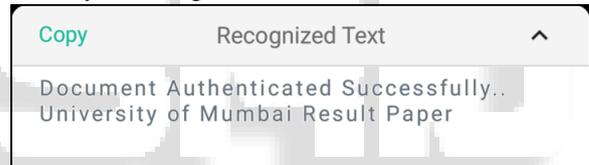
Now the another example to get document authentication,
